TREASURER'S REPORT

June 14, 2021

BALANCE SHEET

For the first time for many months, our cash position is ahead of the balance we had one year ago, by \$16,000. This gives us confidence that we will not exhaust all cash resources over next winter.

The inventory balance (960) has been written off as a result of the disposal of the stale-dated beer inventory.

INCOME STATEMENT

With the strong membership registrations our revenue is almost \$14,000 ahead of the amount expected in the revised budget. In addition, we have \$2,000 more in donations than we had projected.

On the expense side, the greens costs are under-spent by \$3,800 but the combination of Facilities and General Administration are over-spent by \$4,200. The two main causes of these overages are 1) The credit card fees (\$1,300) were not budgeted and 2) the annual water bill from the Park Board (\$1,700) was not budgeted until August. A couple of smaller positive variances (Name Tags revenue and Liquor Licence expenses) bring us to a net surplus of \$17,748 against a budget of effectively break even.

GRANT APPLICATIONS

No word yet on the two grant applications – Local Sports Relief fund (due in May so no news is not good news) and the Community Gaming Grant (due end of August).

INSURANCE

The Bowls BC policy has been renewed at a cost of \$500, up from \$485 last year. This will be paid in June. The separate insurance through Metrix (covering property and liquor liability) is also being renewed at a cost of \$3,750, up \$390 from last year. The budget for both policies was set at \$3,900 so we will be \$350 over spent on this line.

There have been emails regarding an offering of additional Directors and Officers coverage from the broker for Bowls BC which you may recollect seeing. Petra Vanderlay and I have reviewed our existing coverage under the standard Bowls BC policy and the additional coverage we have for the liquor liability through Metrix. It is our recommendation to the board that the existing coverage under these two existing policies is fully adequate and therefore we will not benefit from having an additional policy at extra cost.

SPLBC Board June 14, 2021 President's Report

Member Feedback:

Most of the current feedback has been positive with a few exceptions. Capacity problems seem to be over, and the new members are settling in. The ones I have met so far have all been delighted to be out and bowling. Most issues that have arisen have been settled with some extra communication.

Waiting List for New Members:

With news that the capacity problems are over and with the urging of Dave, I agreed to starting free lessons for potential members again. It was nice to see that the persons on our waiting list did not have to wait very long. Once, the PHO changes opened more rinks, the Back to Bowling committee were able to open a lot more slots.

Opening successes and snags:

We seem to be experiencing great numbers of membership and use of the greens. Great news! Always a couple of snags of course. There is a large increase of bike usage, leading to some difficulties with bike racks. Interestingly, at my last Park Board Stakeholders meeting, the pub was requesting more bike racks around their site as they are experiencing the same thing. We had a formal complaint from our favourite neighbours about the use of the floodlights on Saturday, May 22. I responded with information about our late night sewage repair but we may not have heard the last of this.

Park Board Meeting update:

George and I hosted a visit from Michael Marousek of the Park Board as a preliminary to our new license agreement. We are moving from tenants to license holders which will incur a number of unknown changes. So far, we have been experiencing good response from PB and the city for assistance in diverse areas. But Michael alerted us to some legal requirements that could prove costly and time-consuming. Time will tell.

Minor Points:

I am still trying to change the message on the phones. With the easing of the lockdown, I am proposing to get rid of the puzzle trading table. I think we just need to give a deadline in the newsletter and then the balance would be donated to the thrift shop in the mall.

Clubhouse Report (Wayne Hawrysh)

The only Issue that has arisen in the last couple of weeks is that of clutter (Unused, old and

broken down equipment) that is taking up space in the clubhouse, games shed, around the garden shed and equipment shed.

Last Wednesday, Pat Furlong, Brad Marchand, Gavin Clifford and myself had a bit of a discussion and it was suggested to Pat, to bring up to the Board, to possibly bring in a small container to dispose of said Items. Pat will provide details.

On Wednesday, City Waterworks dug behind the clubhouse to replace a section of the sewage pipe. This should solve the drainage issues. Wayne put up "Do not Use" signage in the washrooms. We hope things will have improved.

Membership Report June 11, 2021

Membership totals 2021 Active Bowlers – 235 both New and Renewals New Bowlers joined in 2021 – 62 Active Social – 43 Unrenewed Social - 49

There is a total of 146 inactive bowling profiles registered in Sumac.

Of that 59 were inactive prior to 2019 which I will eliminate from the database.

Of the 87 remaining inactive profiles 50 became new members in 2019. Of the 50, 34 remain inactive and 16 are currently active.

These totals are reflective of the information provided in Sumac based on information that was originally submitted in 2019 and records updated in 2021.

BBQs

- O Terry Severs will head up the BBQ teams this year. He currently has 1 committed team leader. Possible date for first BBQ could be July 16
- * the committee has suggested, given the events of the past year, perhaps BBQs this summer should be every other week versus every week. The rationale is that we have limited people willing to help, combined with people experiencing reservations around being with large groups of people. The committee felt offering a BBQ every other week could help prevent volunteer burnout, as well as limit exposure to large groups of different people.

Bar Update

- O A group got together at the clubhouse on Sunday, May 30 to dispose of the outdated beer, wine, soft drink and to clean the bar area and fridges. Empties were returned to the Recycle centre.
- O The bar opened Thursday, June 3 for the Blue Heron evening. The process created by Iain was seamless all went very smoothly a little less than half of the people bought a beer or wine. The bar did not open Friday (due to low numbers of people playing), Saturday or Sunday. It would seem the interest at this time is primarily during Blue Heron.

Kitchen Update

- O As the kitchen is still not being used, not much to report. The large fridge is currently being used for the beer and wine. The freezer door is still propped open.
- O \$1800.00 from the NHSP funds that will need to be spent this year. If it's not used for the kitchen, perhaps it should go towards the bowls cabinet extension.

House

O Seems to be a lot of clutter in the shed, garden area and equipment area that could be disposed of; thereby opening up space for the storage of other things. (ie: items stored on

top of the cabinet in the shed that Iain needs for the bar). Perhaps a 'clean up clutter day' could be organized and 1-800-Got-Junk could come pick up all the stuff.

Corporate Board report

Anne reported one company wanting to book June 24th, it was decided that we couldn't yet as per COVID directives.

It was decided to wait until after July 1st new directives for all bookings.

Anne also reported that we have a number of interested companies waiting to book it looks like a full summer.

Keith reported that he has a number of leaders and volunteers lined up so we are effectively ready when given the go ahead.

Bowling Director Report for the June 14 2021 SPLBC Executive Meeting

I have asked for brief reports from my team and will forward them later. There are no compelling problems that I am aware of. Coaching is winding down after a successful and hectic start. A system is in place to teach any subsequent novices. We are also taking steps to encourage novices to play more often, and to encourage experienced bowlers to participate/mentor on novice nights. The Greens are in good shape with few bare areas and not too many divots. Rink directions and borders are being changed regularly to even wear. In Games, leagues are happening and tournaments are in the planning stage (more below). Capacity does not seem to be an issue at present, there are empty reservations on most days.albert

Back to Bowling

I have sent the following to my back to bowling team about step 2 protocols, and some of this may require Board approval/action. I don't think much will happen on this until after the June 15 date for step 2. The difficult part about future steps is that many of the Covid protocols will cease being mandatory but will still be encouraged, so we need to decide what rules we want our members to continue to follow.

June 15th (tentatively) we enter step 2.

- 7. Maximum of 50 spectators allowed (outdoor).
- 8. No spectators allowed (indoor).

Those are the only differences from step one, however the past has shown us that general guidelines from the PHO differ from specific interpretations from VIA sport.

My feeling is that we should continue under the current protocols

- 1 Optional but encouraged sanitization
- 2 Mandatory but not enforced 2 metre spacing off the greens
- 3 Mandatory but not enforced 2 metre spacing and masks indoors
- 4 Mandatory reservations
- 5 Mandatory covid medical forms (Forms not strictly enforced, but attendance can be checked on Skedda)

6 Limit of 50 on grounds

Perhaps in a week (allowing time for further clarification from VIA Sport) we can increase our capacity.

I feel we should retain skedda as long as 5 is in force

I feel we should not have open draws as long as 2 is in force

We should continue to bar non member spectators as long as 5 is in force, and ALL spectators as long as 6 is in force

Bowls Purchase for Grant

I have begun the process for purchasing our bowls, dealing with Vince Mai from PIBC, who is a Henselite Agent.

We asked for 15 new sets of coloured bowls in our grant application as follows Bowls needed (15) two sets of size quadruple zero, two sets of size triple zero, three sets of size double zero, one set of size zero, and seven sets of size two

I have placed an order for Quad and Triple zero bowls from Henselite, likely only black, since coloured bowls were not available in those sizes. Aero doesn't make those sizes, Drakes pride has no local agents, and Taylor has only one model in those sizes(which we already have) so my preference was to have a variety of models even though they were black. Below is a chart showing what is tentatively on order, although the deals are not yet finalized. If I can get Coloured

Double Zero bowls from Henselite I will do so, else I will order them from Taylor Bowls. The Price in the chart may or may not be GST inclusive, but my feeling is that the prices were all in, with 475 for black, 595 for colour and $\sim\!650$ for special colours. I estimate that my total bowls cost will be close to \$9000.00 .

Greens Report for June 14 2021 SPLBC Board Meeting

Here's an update on the greens:

The greens have held up pretty well through the first few weeks of play. We're on a sporadic watering schedule for the past three weeks with the auto sprinklers setting turned off. The strategy is to give a good soaking every 3 days or so and allowing the greens to dry between waterings to promote a deeper roots and a firmer surface. I've augmented the sprinkler and natural soakings with the hand watering of sections that naturally dry out quicker and the sod patches. Results have been good with the sod patches melding in with the turf and reasonably healthy greens with a 90 to 95% playable surface.

The lawnmower blades have been set to just slightly above tournament height.

Dethatching has resumed and the greens sweeper has been efficient for cleaning up the thatch.

Aeration of the center section of the west green will be done sometime in June. Solid tines will be used to punch holes rather than pulling cores. This should be less disruptive to play and require less sand. It's expected that the sand we have outside the main gate should be sufficient to complete this task.

A small amount of new grass seed, for a variety of bent grass that should do well in shade, has been purchased for trial under our trees. We'll be planting some soon.

The Greens Crew has been active clearing the greens and gutters of needles leaves and a variety of other debris that falls from nearby trees. A dozen bricks were purchased and installed to complete the border of Monica's north/west garden between the shop and the games room. Benches are being scrubbed and oiled when time permits. The new umbrellas have been reinstalled and will remain out for the season. A few of the old umbrella stands will be installed beside the benches on the north/west side of the west green. They will be erected when needed on very hot days and potentially during tournaments for competitors and spectators.

The Mandatory/Optional Long Mats sign has been posted in the window beside the games room. Perhaps not all members are aware of this as long mats were not used this past week Wed or Thurs afternoon when significant divot damage occurred on rinks 10, 11, 13 and 15. It's expected to heal quickly if care is taken to lay long mats when the ground is moist.

The Board should consider authorizing the switch of our flood lights to LED to save electricity and so that shades can be installed to prevent lights shining into nearby apartments. Security lights still need to be repaired.

Report [on Skedda] to the Board Prepared by Chris Chapman - June 11, 2021

Currently the only three sessions that are at capacity are Tuesday night Novice, Thursday Morning Solo and Thursday night Blue Heron. Other then those 3 we have open spots during every other session

From May 1^{st} thru June 11^{th} , we have had 2 161 bookings totaling over 3200 hours of bowling. Busiest week was May 28 – June 3^{rd} with 520 bookings and no rain outs

In total 9 sessions have been rained out - 6 of those were during the week of May 21st to May 27th As of June 11th, 230 Members have registered and are using Skedda to book their bowling times. Current Weekly Capacity = 856 bookable spots – The two sessions that are running at full capacity are Tuesday Night Novice and Thursday Night Blue Heron. When possible, we will add more rinks of Triples to these two sessions in the hopes of meeting the full demand.

For other sessions that are not at full capacity I have been closing rinks in order to consolidate the bookings. We were getting two many partially filled rinks and closing some rinks seems to be helping us fill the rinks that are open.

In my opinion, Skedda continues to meet our needs and the members seem to have a good grasp on how to make their bookings.
