President's Report

Land Acknowledgement

We are honoured to live and play on the unceded territory of the Coast Salish Peoples, the Musqueam, Squamish, and Tsleil-Waututh Nations.

This Season's Plans (fingers crossed)

Welcome Back! We are so pleased to be able to offer a full season of bowling and socials. Things are looking up, optimism is everywhere and so we are making many, many plans for this season. But of course, we all know that conditions can change. We have hope that lockdowns will not be necessary again. So, our plans are based on freedom of movement and gathering, without fear. However, we are prepared to pivot, if necessary.

So much is happening: Open House plans are in full swing...our first since 2019! A V&D Handbook of interclub tournaments has been printed and is available. We have agreed to host a Provincial championship here at the club. Mixed Pairs. Socials and BBQs are in the early stages of planning. It will be up to you, the members to let us know how many socials you would like. Only by members volunteering to do these things happen. You will hear a lot today and the calendar is filling up.

Budgets are best guesses

Budgets by definition are a financial guess. At the end of our year, in September, we look at the past costs and make estimates on the next year. One of our major problems is that we budget in the fall and both Bowls Canada and Bowls BC budget in the spring. So, we make an educated guess on their fees to us and have had a few surprises in the spring. The biggest surprise this year is that they have changed the way they calculate their fees. We are now being charged a flat amount based roughly on our size in 2019. It has nothing to do with how many members we have this year. The good news is it is less than what we paid in 2019. The bad news is it is more than we budgeted (based on the lack of full fees in 2020 and 2021). It has also adjusted how we self-assess the GST on membership fees. So, our fee this year on renewal of bowling membership is now the \$250 but plus GST of 5%, so equals \$262.50. Social membership will be \$75 plus GST = \$78.75. You will hear more details of this plus other budget variances from our Treasurer.

Projects:

There are lots of on-going projects to improve our club. We have budgeted for new plinths on the East Green. We have also planned in our last grant for increased bowl storage. And we managed to win a new grant to improve our irrigation system and buy a new electric mower/verticutter. Many thanks to the Capital Projects Team for obtaining \$25,000. for this. However, contractor and parts availability are affecting timing to some extent.

New Logo, New Shirts

Thanks to Graham Mason for the improvements to our Logo. There is a lot of talent in our membership. And a big thank you to the Shirt Committee for the design, rollout and orders for our new club shirt. They should arrive shortly.

Bowls Canada, Bowls BC and Park Board:

Just a little review of our official structure and some interesting numbers. According to Bowls Canada, there are about 18,000 bowlers in Canada: of these, 6,000 here in BC, 9,000 in Ontario and the other 3,000 spread out over the rest of the country. Here in BC, there are 4 districts: North Island, South Island, Interior and us, Vancouver and District. Popularly called V&D, it has about 2,500, close to half of the province. V&D contains 22 clubs, 7 of which are in Vancouver proper. We are the largest of these but have been unable to confirm whether we are still the largest club in Canada, by membership. As to size, there are several 4 green clubs across the country.

Over the winter, we have attended meetings with each and all of these organizations, including participating in the Park Board Traffic Study. And more to come.

Communications:

With the clubhouse being closed essentially the last two years and bowling happening under strict guidances, I don't know how we would have managed to stay together without good communications. We must acknowledge the wonderful work of Lynda Brennan who edits and publishes our newsletter to keep us all in the know. And then there is Mike Smolnicki, our tech guru, who manages the website and has worked hard with the teams to develop our online registration and enhanced payment options. Thanks also to Chris Chapman for his role in improving payment ease and reporting.

By the way, the weekly goal is to issue newsletters for Sunday breakfast morning readers. During the busy times, mid-week Wednesday morning tends to be the norm for a second newsletter. Please read all the way to the bottom as there is lots of information communicated there.

Corporate Rentals

2022 Budgeted at \$28 000.00

Thursday Afternoons are the primary time slot but we do offer clients both a Tuesday and Friday Afternoon option as an alternative.

Currently there are 3 Thursdays still available in June plus 1 in August and 2 in September. All other Thursdays have been booked.

Currently we have 13 bookings for approx. 535 participants with most groups booking \$40 Bowling plus \$10 Social. Total estimated income \$25 000.00

At this stage we are confident we will be able to meet the budget and will do everything we can to ensure it.

A huge thanks to both Keith and Anne for the work they do on the Corporate Rentals.

I would also like to thank the following people who have volunteered to be group leaders this year;

Sue Smolen, Judy McInerney, Jane Spencer and Lois Goodeve.

The team leaders will need an army of volunteers to help during each rental and will be calling on the membership to give them a hand. Corporate Sponsorship

After Lynn Kennedy and I looked at what other clubs were doing, I came up with a variety of corporate sponsorship opportunities for consideration. These included Tournament Sponsors, Friday Night BBQ Sponsor, advertising signs on our Score Boards, Rakes, Draw Table and Benches to go along the south hedges.

From there I had 2 people with experience in purchasing community-based advertising value each of the opportunities plus I looked at what other clubs were charging for similar things and determined that we could generate up to \$20 000.00 per year to go towards capital projects.

A presentation was then made to the board and after a lengthy discussion the board decided that we should stick to our current club policy of no Corporate Sponsors.

I would like to thank Lynn Kennedy, Tania McQueen and Dave Sullivan for their input and feedback as well as their willingness to sit on the sponsorship committee had we proceeded with a program.

POS System

Last year we introduced payment by debit and credit card and the feed back has been very positive.

Going forward we are going to try to streamline all sales to go through the POS system making it easy for members to buy event tickets, pay tournament fees, purchase drinks, BBQ food, pro shop items etc.....

We are working to develop a team of 12 cashiers that when at the club will open the bar and take your payments for anything that you need to pay for. If this is something that you would be interested in helping out with, please see me after the meeting.

Starting today you can fill out your membership form plus pay for your membership, locker rental, name tag and club house fob online using your credit card. You can go to the club's website and follow the link to pay online by credit card.

A debit card payment at the club costs the club \$.10 per transaction

A credit card payment at the club costs the club 2.65% of the total purchase including taxes

A credit card payment done online costs the club 2.9% plus \$.30 per transaction.

For a bowling membership with locker the total cost is \$273.00 including taxes.

Debit card at the club costs the club \$.10, Credit card payment at the club costs

\$7.23 Credit card payment done online costs \$8.22

Report to SPLBC Board of Directors April 2022 Past President - Eva Murray

1. CPR/AED Training

This was completed on March 22, with five participants - Wayne Hawrysh, Joan Lynch, Janice Krieger, Donald Robertson, and Eva Murray. Our AED has been tested and is in working order.

2. Membership

My SGM talking points will serve as an overview of processes for membership renewal, Open House, liaison with Coaching, and new member registration.

The trend has been toward increased use of technology and increased use of non-cash payments. Let's remember the range of understanding and level of comfort with the trends. For those leading the change, we urge simplicity of process and clarity of language to make a smooth transition.

Thanks to those who have consulted with the Membership Team and have helped us.

3. Board Development

I've been pondering our understanding of the Board Chair not voting and wondering if this is really true. I've checked with people on boards, chairing boards, and providing board training. I've also checked the literature. In brief, anyone chairing a meeting who is also a member of the organization has a right and a responsibility to vote.

The Chair's role is to manage the meeting, to be the facilitator. The Chair can speak, make motions, and debate. The Chair only voting to break a tie seems to be a myth.

There are a number of cautions:

- Chairs must always convey fairness and neutrality in leading the meeting and the motions.
- Chairs wishing to make motions and speak to them, should relinquish the chair to someone else to manage the discussion and vote.
- A tie vote is not a majority, so the motion is defeated.

As such, I believe this should be documented for future reference. I move that at all SPLBC Board and Member meetings, the Chair can make motions, provide clarification and opinions, and vote.

Liaison & Communication

During the season, regular communication between the house team and the various groups that use the clubhouse, will be necessary. The clubhouse is vital in the day to day running of the club as a whole.

Security

We have installed a new self locking mechanism in the greens equipment shed. This will help with securing the shed, as there have been a few incidents of it being left open. We continue to use Securiguard for twice weekly random checks. A new security lighting system has been installed to help with keeping our facility safe and secure.

Our Role as Members

We, as members of SPLBC need to keep our clubhouse clean and safe. Everyone should be committed to cleaning up after themselves and do as much as possible to keep our garbage and recycling programs running smoothly. Please be conscious of putting your trash in the proper receptacle.

SGM Greens Report 2022 (Gavin Clifford)

What's Been Done

On March 24 (West) and March 27 (East) a team of volunteers completed the aeration and topdressing (coring & sanding) of our greens. Top seeding of both greens was done during the process and the sprinklers, which had just been activated by Van Parks, were used to soak in the new sand and seeds. Mother Nature is cooperating so far with a mix of sun and rain, almost perfect for seed germination although it could be a few degrees warmer. Everything went smoothly including the delivery of our two 6 tons each. A small supply of excess sand has been stored in the sand bin and will be used for patch work throughout the season.

What's New

Work is being done to repair the short retaining walls of the centre garden. Contrary to popular belief, our sod nursery survived the winter and patches of sod have already been transplanted to our greens. This experiment is ongoing but results have been promising for the patch repair of trouble spots on the greens. The Parks Board provided another full skid (approx 30 wheelbarrows full) of top soil/compost for our gardens this year. The soil was quickly distributed by the greens team to various gardens on club grounds. An electric leaf blower has been purchased along with a second 40V battery pack. The two batteries will power the weed trimmer and blower and the new blower will be effective for small clean up jobs. The large gas blower has been retained for bigger "wet debris" clean up jobs. The arrival installation of new sprinkler heads is expected sometime in June. The new sprinklers should give our greens more uniform and consistent coverage. A new electric mower has been purchased and should be delivered in August.

Greens Status

The Greens are looking good, quickly recovering from a severe case of snow mold that developed in the winter as a result of a fungicide that was applied and the coring and sanding. It's looking like we should get full use of all rinks in the coming season and there are no large areas that will require roping off. Watering will be closely monitored and Brad has been reprogramming the sprinkler system. There will be less water delivered to the cool shady areas and the implementation of a hand watering schedule for the dry spots if needed. The new sprinkler system should hopefully be in place by late June. The goal, as always, is firm flat greens. There are no plans at present to have any rest periods for the greens.

Greens Protocols

Members are reminded to limit damage to the greens in high traffic areas such as on the edges of the greens (Approximately the first 2 metres). Moist turf, especially early in the season, can be very delicate. Take care on the delivery of your bowls. Play short jacks and use the long mats early in the season. We are well aware that using the long mats can be a pain but they are very effective at preventing divots. A single game of bouncing bowls can cause turf damage that may take weeks to repair. Preventing divots is not just a job for the skip, it is something we can all help prevent. Proper footwear is very important for maintaining good greens. Flat shoes without heavy treads are required for bowling. There has been evidence of greens damage in the past, so there will be some random checks, to ensure that members are adhering to this. Please check the website to confirm if the greens are open or closed.

How To Help

The Greens Team meets on Wednesday mornings, and they volunteer for various tasks both on the greens and around the clubhouse. Show up at the club around 9 AM to help out, or contact Gavin Clifford for information. Other tasks that may need doing through the week include filling crow holes, clean up of debris that's blown onto the greens. If you are a morning person, removing the morning dew around 8:00 is an important means of disease control. Check with Gavin about brushing the dew. Our hired Greenskeeper, Scott, is dedicated to providing us with the best bowling surface possible. He receives direction from the Greens Team Leader as developed by the Greens Committee. Explaining the greens maintenance program and responding to critiques from members, is not a good use of his time. Should you have questions or concerns about how the greens are being looked after please contact the Greens Team Leader – Gavin Clifford
